

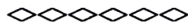

In the reference 6<sup>th</sup> cited, the competent authority was granted Extension of Temporary Recognition to Classes I to VII (English Medium) during the academic year from 2006-2007 to 2015-2016 in respect of **“Sri Sai Saraswathi Vidyaniketan School, H.No.8-3-231/A/501, Srikrishna Nagar, Yousufguda, Khairtabad Mandal-II, Hyderabad”**.

After careful examination of the references 1<sup>st</sup> to 5<sup>th</sup> Cited, as per G.O.Ms.no. 1 Edn. Dt. 1-1-94 read with G.O. Ms. No. 52 Edn. Dt. 28-2-98, G.O.Ms.No.41, Dt.11-05-2006, G.O.Ms.No.74, Dt.02-07-2006 and G.O.Ms.No.58, Dt.13-07-2006 and G.O.Ms.No.88, Dt.07-07-2008 and as per the recommendation of the Deputy Inspector of Schools, Khairtabad Mandal-II, Hyderabad, vide reference 7<sup>th</sup> Cited, the District Educational Officer, Hyderabad District is pleased to grant Extension of Temporary Recognition to Classes I to VII (E.M) during the period from **2016-2017 to 2025-2026** in respect of **“Sri Sai Saraswathi Vidyaniketan School, H.No.8-3-231/A/501, Srikrishna Nagar, Yousufguda, Khairtabad Mandal-II, Hyderabad”** subject to the condition that the management shall fulfill the following conditions:

1. That Class rooms with an area of not less than 240 S.feet at the rate of one for each section in case of Upper Primary and Secondary sections at the rate of one for every 40 students in case of primary sections shall be provided.
2. That adequate accommodation for the staff, Library and Laboratories shall be provided.
3. That adequate sanitary facilities and water including drinking water shall be provided.
4. That adequate furniture, Library books, Lab equipment and play material shall be provided.
5. That sufficient number of qualified staff shall be appointed.
6. That the **Sri Sai Saraswathi Vidya Niketan Society** shall prescribe the scales of pay to the teaching and non-teaching staff.
7. That the educational institutions shall serve the needs of the locality.
8. That the Educational Institutions shall adopt the curriculum, syllabus, text books and work books prescribed by the government.
9. That the Educational Institutions shall follow the school timings mid-term holidays and vacation as prescribed by the government.
10. That the results of the institutions in VII and X Class Public Examinations shall be satisfactory.
11. That the administrative report and the audited statement of accounts of the school duly attested by the Chartered accountant for every financial year shall be submitted to the District Educational Officer, latest by September.
12. That the list of the Governing Body shall be furnished to the District Educational Officer every year.
13. That the pay structures/fee structures fixed by the governing body shall be submitted and get it approved in the District Educational Officer.

14. That the Educational Institutions shall provide facilities for teaching Telugu as First/Second Language in the school.
15. That under aged children shall not be admitted or promoted to any class.
16. That any children studied in recognized school of other states/countries affiliated to the bodies recognized by the state or central government shall not be admitted without prior permission of the District Educational Officer/Director of School Education.
17. That children from an unrecognized shall not be admitted.
18. That admission shall not be denied on the grounds of religion, caste, race or language.
19. That any student shall not be detained in the same class against government orders.
20. That the students shall not be promoted from one class to another class as per the existing government orders.
21. That corporal punishment shall not be imposed to a student.
22. That the management shall not collect any fees or donations either in cash or kind other than the fees prescribed by the governing body from pupils or parents or any other person or on their behalf for any purpose.
23. That any candidate whose certificate is suspended and who has been convicted for offences involving moral turpitude shall not be appointed.
24. That all records and registers prescribed by Government shall be maintained.
25. That the Educational Agency shall not carry on or encourage propaganda or practice wounding the religious feelings of any citizens of INDIA or insult the religious belief or indulge in any act that undermine national integrity and insult the national anthem and national flag.
26. That educational agency shall not force any member of the staff or students of the institutions to take part in the religious discourses and preaching of religion irrespective of whether they belong to the same belief or not.
27. That educational agency shall not refuse to constitute the institution as centers for conducting common public examinations like Class X, VII Class and other departmental examinations as directed by the department.
28. That the permission of the competent authority shall be taken to run the institution in shift system.
29. That educational agency shall maintain proper sanitary conditions in the institution.
30. That educational agency shall take up regular repairs to up keep the school building.
31. That educational agency shall not use the premises building, play ground and vacant site belongs to the institution for any purpose other than the institutional activities and conducting authorized examinations without the permission of District Educational Officer.
32. That educational agency shall not permit the students of any college of education or college of physical education or any teacher training institution to have teaching practice without the permission of the District Educational Officer.
33. That educational agency shall carry all the instructions issued by the departmental officers relating to making of admissions of students, appointment of staff and also other academic and administrative affairs in the interest of academic standards and smooth functioning of the institutions.
34. That all the conditions prescribed in the G.Os and other orders which are not specified in the order shall be completed with.
35. The management shall apply for the renewal of recognition six months in advance before expiry of the present recognition with all the certificates mentioned in Annexure-I and other decrees or certificates as per G.O.Ms.No. 1 dt. 1-1-1994. The incomplete proposals and the proposals received after due date will not be considered. The Educational Agency will be solely responsible for the non-submission of the proposals in complete shapes on or before the due date.

Permission/ Extension of Temporary Recognition has been accorded to the Class (s) VIII to X (E.M) for the years 2018-2019 in respect of Sri Sai Saraswathi Vidyanikethan School, Sri Krishna Nagar, Yousufguda, Hyderabad District in the orders 5<sup>th</sup> cited. The inspecting authority has submitted the report for provisional recognition to the school for the years 2018-2019 to 2027-2028 vide letter 6<sup>th</sup> cited. The Dist. Ednl. Officer, Hyderabad Dist. has verified the application for provisional recognition with reference to the inspection report of the Inspecting officer and also with reference to the conditions laid down in the permission order/previous recognition orders and G.O Ms.No.1Edn, (PS.2) Dept, dt.01.01.1994 and submitted a report in his letter 7<sup>th</sup> cited.

After careful examination of the references cited and the conditions prescribed in G.O. Ms. No.1/Edn, (PS.2) Dept, dt.01.01.1994 and based on the recommendations of the DEO, Hyderabad Dist., the Regional Joint Director of School Education, Hyderabad hereby accorded Provisional/ Extension of Temporary Recognition to Class(s) VIII to X (E.M) for the years 2018-2019 to 2027-2028 in respect of Sri Sai Saraswathi Vidyanikethan School, Sri Krishna Nagar, Yousufguda, Hyderabad Dist. subject to fulfillment of conditions as detailed below:

1. That the Educational Society shall abide by the instructions/rules issued by the Govt. from time to time.
2. That the educational Society shall serve the needs of locality more particularly.
3. That the institution shall adopt the curriculum and syllabus prescribed from time to time by the State Government.
4. That the school timings, vacations and mid-term holidays shall be as prescribed by Govt. from time to time.
5. That the qualified staff within age limits prescribed by the Govt. for Government employees shall be appointed as per the staff pattern as per G.O Ms.No.103 Edn (PS), dt.05-08-2005.
6. That the results shall be satisfactory every year and not to be announce the ranks in SSC Public Examinations as per the G.O Ms.No.49 Edn. (PS), dt.26.02.98.
7. That the records/accounts shall be furnished to the D.E.O every year by 31<sup>st</sup> March, at the latest.
8. That the list of governing body shall be furnished to the DEO every year.
9. That the pay structure / fee structure fixed by the governing body shall be got approved by the DEO every year.
10. That all the conditions prescribed in G.Os and other orders which are not specified in this order shall complied with.
11. That the school shall not be closed without giving notice both the Parents/DEO and competent authority at least (6) months before.

12. That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
13. That the society shall submit proposals for renewal of provisional recognition sufficiently in advance i.e., at least (6) months prior to the date of expiry of the renewal.
14. That additional sections/higher classes should not be opened without prior permission of the competent authority.
15. That the recognition is accorded to society and no other society or body can open a school on their behalf.
16. The recognition is accorded to open the school premises in the locality and there shall not be any change in the premises or locality.
17. The society shall provide the necessary material even if it costs more than the deposit amount.
18. Admissions should be made on the basis Record sheet issued by the Private Recognized/ZP/Govt/Aided schools only T.Cs/Certificates issued by the Secretary, DCEB as Bonafide candidate.
19. The Edn. Society shall file an affidavit to the effect that there is no deviation or violation of norms/rules prescribed by Govt. from time to time by the end of April every year as per G.O.3<sup>rd</sup> cited.
20. The above E.T.R. is granted subject to condition that, If it is found later that the school has not fulfilled the prerequisite condition under A.P. Edn. Act 1982, reported by State Level Inspection Team and Vigilance Committee, the E.T.R. now being granted is liable to be withdrawn at once.
21. The Management shall provide sufficient transportation, sufficient fire extinguishers in the school.
22. The Management is totally responsible in all aspects for the safety of school children. They will be personally held responsible if any incident occurs.
23. The Management shall handover the school premises whenever required to this department / Government for emergency purpose (Exams/ Elections etc.) without any deviation of the orders.
24. G.O.Ms.NO.22, dt.18.07.2017 must be compulsorily followed i.e., the weight of School bag not to exceed 4 Kg for VI-VII, 4.5 Kg for VIII -IX and 5 Kg for X.
25. The Management not to run I.I.T. and Medical entrance foundation courses as permission of Renewal Recognition is given only for school.
26. Sanitary & Soundness certificate should be renewed timely and must be submitted to the District Educational Officer, concerned.
27. The Correspondent is instructed to Renewal Lease deed time to time when it's get expired.
28. TPF Scheme to be implemented to all Teachers.
29. The Management shall renew NOC from Fire Department from time to time without fail.

The recognition now granted is liable for withdrawal by the competent authority for violating the rule as prescribed in the G.O's cited and instructions issued by the authority from time to time.
